8.	How many times you can accept the Offer	Once per site on which the solar system is being installed.
9.	How you will receive the Offer	<p>If you select the 300kW Magneto Portable Battery Backup device OR 2x Solar Panels, you will receive the added-value item at the time of installation.</p> <p>If you select the cleaning and maintenance service, you may book this at any time during the two-year period after installation. A maximum of 4 cleaning services will apply during that period. We</p>

		recommend that you arrange the service at least every six months.
10.	Other terms	<p>This offer is only applicable on the solar system, and not fixed backup systems (i.e. systems without solar panels).</p> <p>You cannot take up this offer if you received a quotation, paid a deposit or had a solar system installed before 1 November 2023.</p> <p>Should the added-value item of your choice not be available at the time of installation, we reserve the right to replace it with an item of a similar value. You will be notified prior to a replacement being made.</p> <p>The added-value item you choose will appear on the final quotation that we send to you. You may not change the added-value item after you accept the quotation.</p> <p>Should you select the cleaning and maintenance services and the services become unavailable during the two-year period, we reserve the right to substitute any cleaning services still due to you with a voucher for a similar service and value.</p> <p>If you cancel the quotation after accepting it or cancel an installation that has been booked, this Offer will lapse and you will not be allowed to claim the added-value item. You will forfeit (give up) any cleaning services you do not arrange within the two-year period.</p>
