5.	What are the requirements to enter the Competition?	You may enter if you are: 5.1 18 years old or older and reside in South Africa; 5.2 an existing Standard Bank transactional account holder who is KYC compliant and not in breach of the product terms; and 5.3 Qualify to take up a Standard Bank Evolve product (Achieva Evolve, Evolve Professional, Evolve Prestige, Evolve Private or Evolve Signature)

9. GENERAL

- 9.1 Please pay special attention to the clauses that are in bold, as they may limit our liability (responsibility) or involve some risk to you.
- 9.2 We are the promoter of the Competition. Any reference to **we/us/our** includes our directors, sponsors, agents or consultants, where the context allows for it.
- 9.3 These Terms are governed by the Consumer Protection Act 68 of 2008.
- 9.4 These Terms apply to the Competition and all information relating to the Competition (including any promotional or advertising material that is published).

- 9.5 By entering the Competition, you are bound by these Terms and if applicable, the terms of the Prize and the Standard Bank product terms and conditions that relate to the Competition or the Prize.
- 9.6 If the Prize involves any goods or services provided by a third party, the Prize will be subject to the third party's terms and conditions.
- 9.7 ***We reserve the right to amend these Terms.***

9.17.3 suppliers of any goods or services under the Competition.
