TERMS AND CONDITIONS (TERMS) FOR THE BLACK FRIDAY WINE OF THE MONTH
CLUB PROMOTIONAL OFFER**

Please read the Terms carefully and pay special attention to the clauses that are in bold, as they may limit our liability (responsibility) or involve some risk to you.

1. INTRODUCTION

- 1.1 Receive 5% cashback (up to a maximum amount of R100.00 (one hundred Rand)) when you purchase any items from the Wine of the Month Club online store using your Standard Bank credit, cheque, debit or virtual card (**Card**) on Black Friday 2020 (**Offer**) – this Offer is limited to the first 750 (seven hundred and fifty) customers who purchase items on the Wine of the Month Club online store using their Card on Black Friday.
- 1.2 The Offer starts at 00:00 on Friday, 27 November 2020 and ends at 23:59 on Friday, 27 November 2020 (**Offer Period**).

2. WHO QUALIFIES FOR THE OFFER

To qualify for the Offer, you must meet the following requirements:

- 2.1 be 18 years or older;
- 2.2 permanently reside in the Republic of South Africa;
- 2.3 be the holder of a valid and active Card, whose Card account is in good standing.

3. HOW TO ACCEPT THE OFFER

- 3.1 The first 750 (seven hundred and fifty) customers to purchase items on Wine of the Month Club online store using their Card during the Offer Period will receive 5% cashback (limited to a maximum amount of R100.00 (one hundred Rand)), credited to their Card account.
- 3.2 If you comply with the requirements set out in clause 2 above and this clause 3, you automatically qualify for the Offer.
- 3.3 You may only take up the Offer once during the Offer Period.
