

**STANDARD INSURANCE BROKERS PROPRIETARY LIMITED (SBIB/WE/US/OUR)
TERMS AND CONDITIONS IN RESPECT OF THE GET A QUOTE COMPETITION (COMPETITION)**

Important clauses, which may limit our responsibility; place an obligation on you to indemnify us; involve an acknowledgment of any fact; or involve some risk for you, will be in bold and italics. You must pay special attention to these clauses.

1. DURATION

The Competition starts at 00:00 on Wednesday, 26 June 2019 and ends at 23:59 on Friday, 25 October 2019 (**Competition Period**).

2. ENTRANT REQUIREMENTS

To qualify as an entrant into this Competition you must meet the following requirements:

- 2.1 be 18 (eighteen) years of age or older; and
- 2.2 permanently reside in the Republic of South Africa.

3. HOW TO ENTER

- 3.1 To enter the Competition, you will need to get a telephonic insurance quote from us as follows:

- 3.1.1 watch the Espresso Morning Show on SABC 3 (the **Espresso Show**) on Wednesdays during the Competition Period from 06h00 to 09h00;

- 3.1.2 sms the relevant keyword as seen during the SBIB insurance insert on the Espresso Show to **31492** (free and bundled sms's do not apply); and

- 3.1.3 receive a call back from us with an insurance quote.

- 3.2 You may enter the Competition as many times as you want, as long as you follow the steps in clause 3.1 to obtain a telephonic insurance quote **for a different insurance product** each time.

- 3.3 You will not be eligible to win more than one Prize.

- 3.4 There are no forms to fill in and once you meet the requirements set out in clause 2 above and this clause 3, you will automatically be entered into the Competition.

- 5.2.1 you are a director, member, partner, employee, agent or consultant of ours; or

- 5.2.2 you are an immediate family member of any of the persons specified in clause 5.2.1.

- 5.3 These terms and conditions are governed by the Consumer Protection Act 68 of 2008, which will apply to this Competition and all other information relating to this Competition (including any promotional or advertising material that is published).
- 5.4 By entering this Competition all entrants agree to be bound by:
- 5.4.1 these terms and conditions; and
- 5.4.2 any third-party supplier terms and conditions.
- 5.5 ***We will need to process your personal information to validate your entry and if you are a Prize winner, to make the Prize available to you. By entering this Competition, you consent to us processing your personal information for this purpose. If you do not consent to us processing your personal information, please do not enter this Competition***
- 5.6 ***No entry will be considered to be valid until a validation process has taken place.***
- 5.7 The Prize winners will be chosen by means of lucky draws conducted by our risk assurance partners at 30 Baker Street, Rosebank, Johannesburg as follows:
- 5.7.1 first lucky draw will be conducted on 16 July 2019;

- 5.7.4 fourth lucky draw will be conducted on 17 September 2019;

- 5.9.2 winner of the second lucky draw, by no later than 9 August 2019;
- 5.9.3 winner of the third lucky draw, by no later than 30 August 2019;
- 5.9.4 winner of the fourth lucky draw, by no later than 20 September 2019;
- 5.9.5 winner of the fifth lucky draw, by no later than 11 October 2019; and
- 5.9.6 winner of the sixth lucky draw, by no later than 1 November 2019.
