TERMS AND CONDITIONS (TERMS) FOR THE MAKRO BLACK FRIDAY
PROMOTIONAL OFFER**

Please read the Terms carefully and pay special attention to the clauses that are in bold, as they may limit our liability (responsibility) or involve some risk to you.

1. INTRODUCTION

1.1 We are offering the first 750 (seven hundred and fifty) clients who use their Standard Bank credit, cheque, debit, commercial or virtual card (**Card**) to pay for their purchases of R500.00 (five hundred Rand) or more at Makro stores (***whether in-store or online***) during the Offer Period (defined at clause 1.2 below), a R100.00 (one hundred Rand) Makro voucher (**Offer**).

1.2 The Offer starts at 00:00 on Friday, 26 November 2021 and ends at 23:59 on Friday, 26 November 2021 (**Offer Period**).

2. WHO QUALIFIES FOR THE OFFER

To qualify for the Offer, you must meet the following requirements:

2.1 be 18 years or older;

2.2 permanently reside in the Republic of South Africa;

2.3 be the holder of a valid and active Card, whose Card account is in good standing.
