

## **THE STANDARD BANK OF SOUTH AFRICA LIMITED (STANDARD BANK/WE/US/OUR): TERMS AND CONDITIONS FOR THE STANDARD BANK/MASTERCARD CASHBACK OFFER (TERMS)**

Please pay special attention to the sections that are in bold. These are important clauses that may limit our responsibility or involve some risk for you.

### **1. ABOUT THE OFFER**

- 1.1 The first 3 000 clients that use their Standard Bank corporate credit card (**Card**) during the promotion period (defined in clause 1.2) have the chance to receive a 5% cashback on their highest value purchase made during the promotion period, up to a maximum of R150.00 (**cashback**).
- 1.2 The offer starts at 00:00 on Monday 13 December 2021 and ends at 23:59 on Sunday, 9 January 2022 (**promotion period**).
- 1.3 **We may change these Terms at any time, including the start and end dates of the offer. By taking part in this offer, you agree that the latest version of these Terms applies to you.**

### **2. WHO QUALIFIES FOR THIS OFFER**

- 2.1 To qualify for the cashback, you must:
  - 2.1.1 be the holder of a Card, whose Card account is in good standing (in other you are not in breach of the terms and conditions which apply to your Card);
  - 2.1.2 have made a successful purchase at Caltex for over R1500 during the promotion period (in other words the purchase has not been reversed for any reason).
- 2.2 The criteria in clause 2.1 are collectively referred to as the **qualifying criteria**. **We may, at our sole discretion, decline any person who does not meet these qualifying criteria.**

### **3. HOW THE OFFER WORKS**

- 3.1 We will let you know by the end of January 2022, by way of SMS, if you are one of the first 3000 clients to meet the qualifying criteria. You can only take up the offer once during the promotion period.
