

THE STANDARD BANK OF SOUTH AFRICA LIMITED (STANDARD BANK/WE/US/OUR)
TERMS AND CONDITIONS (TERMS) FOR THE UKHOZI FM MYMO COMPETITION
(COMPETITION)

Please read the Terms carefully and pay special attention to the clauses that are in bold, as they may limit our liability (responsibility) or involve some risk to you.

1. DURATION

The Competition starts at 06:30 on Monday, 7 December 2020 and ends at 18:00 on Friday, 11 December 2020 (**Competition Period**).

2. REQUIREMENTS

To qualify for the Competition, you must:

- 2.1.1 permanently reside in the Republic of South Africa;
- 2.1.2 be 18 years or older;
- 2.1.3 you are an existing account holder of a Standard Bank MyMo transactional account (**MyMo Account**) whose account is in good standing.

3. HOW TO ENTER

- 3.1 Every day during the Competition Period you must call the Ukhozi FM (**Radio Station**) during the Sisonke Drive show when the Radio Station presenter is promoting the Competition and if your call is answered you will compete in the daily MyMo quiz against another entrant (**Quiz**). *Standard Network rates apply.*
- 3.2 The entrant who answers the most numbers of questions correctly in the Quiz will win the First Prize and the second entrant will win the Second Prize.
- 3.3 There are no forms to fill in and once you meet the requirements set out in clause 2 above and this clause 3, you will automatically be entered into the Competition.

4. PRIZES

- 4.1 Every day during the Competition Period, 2 persons stand the chance to win the following cash prizes:

- 4.1.1 The first prize will be an amount of R5 000 (**First Prize**); and
- 4.1.2 The second prize will be an amount of R2 500 (**Second Prize**).
- 4.2 The First Prize and Second Prize are collectively referred to as the (**Prize**).

5. GENERAL

- 5.1 We are the promoter of the Competition. Any reference to **we/us/our** includes our directors, sponsors, agents or consultants, where the context allows for it.
- 5.2 These Terms are governed by the Consumer Protection Act 68 of 2008.
- 5.3 These Terms apply to the Competition and all information relating to the Competition (including any promotional or advertising material that is published).
- 5.4 By entering the Competition, you are bound by these Terms.
- 5.5 ***We reserve the right to amend these Terms.***
- 5.6 ***We must process your personal information to validate your entry and if you are a Prize winner, to make the Prize available to you. By entering the Competition, you consent to us processing your personal information for this purpose. If you do not consent, please do not enter the Competition.***
- 5.7 The First Prize and Second Prize winner will be chosen in terms of clause 3.2. This process will be overseen by the Radio Station's risk governance department on 15 December 2020 at SABC KZN Regional Office, 100 K.E. Masinga Road, Durban. The Prize winners will be notified immediately after the Quiz is completed.
- 5.8 Once the Prize winner accepts the Prize, it will be deposited into the Prize winner's MyMo Account within 30 days of the notification.
- 5.9 ***We may declare the Prize forfeited (lost) and we may choose a new Prize winner, if:***
 - 5.9.1 ***a Prize winner's entry is not valid.***
 - 5.9.2 ***a Prize winner has breached these Terms.***

- 5.9.3 ***a Prize winner cannot be contacted or does not accept the Prize within 3 days from the date that the Prize winner was contacted about the Prize.***
- 5.9.4 ***a Prize winner gives up the Prize or we determine that the Prize winner has given up the Prize.***
- 5.10 If there is a dispute in respect of these Terms or the Competition, our decision is final and binding and no correspondence will be entered into.
- 5.11 If the Prize winner agrees to it, we may publish their name and/or photo in any internal or external advertising or promotional material for 12 months from the date on which the Prize winner accepts the Prize. We will determine the nature and distribution of these materials. If a Prize winner does not consent to the publication of their name and/or photo, the Prize winner will still receive the Prize.
- 5.12 The Prize may not be exchanged for any other item. We do however reserve the right to substitute the Prize with any other prize of a similar commercial value.
- 5.13 ***We are not responsible if your entry is not successfully submitted or a Prize winner does not successfully receive or take up a Prize for any reason, including because of a technological failure.***
- 5.14 ***We are not responsible for any loss or damage which you or any third party may suffer as a result of you participating in the Competition or accepting a Prize.***
- 5.15 ***If required by the Minister for Trade and Industry, the National Consumer Commission or for any other reason, we can end the Competition immediately with or without notice to you. If this happens, you waive (give up) any rights which you may have against us and you will have no claim against us.***
