

**THE STANDARD BANK OF SOUTH AFRICA LIMITED (STANDARD BANK/WE/US/OUR)
TERMS AND CONDITIONS (TERMS)
IN RESPECT OF THE
STANDARD BANK MOBILE COMPETITION (COMPETITION)**

Please read the Terms carefully and pay special attention to the clauses that are in bold, as they may limit our liability (responsibility) or involve some risk to you.

1. DURATION

The Competition starts at 00:00 on 20 December 2021 and ends at 23:59 on 24th January 2022 (“**Competition Period**”).

2. ENTRANT REQUIREMENTS

To qualify as an entrant into this Competition you must meet the following requirements:

- 2.1 be 18 (eighteen) years of age or older;
- 2.2 permanently reside in the Republic of South Africa; and
- 2.3 hold a valid Standard Bank account in your name.

(“Qualifying Entrants”)

3. HOW TO ENTER

3.1 To enter the Competition, Qualifying Entrants must:

- 3.1.1 follow the Standard Bank Facebook or Twitter page;
- 3.1.2 like the Standard Bank Facebook or Twitter post that mentions the Competition;
- 3.1.3 share the Standard Bank Facebook or Twitter post that mentions the Competition and include the hashtag [#HowAboutNowSummer](#) into your shared post.

3.2 Qualifying Entrants may enter the Competition once during the Competition Period and will only qualify for one Prize.

- 3.3 Each Qualifying Entrant who meets the requirements set out in this clause 3.1, will automatically be entered into the Competition.

4. **PRIZES AND LUCKY DRAW**

The Competition prizes are as follows:

- 4.1 An iPhone 12 mini with Apple Air Pods in black or white (depending on stock availability) ("**Prize**") will be awarded every week during the Competition Period to one Qualifying Entrant who meets the requirements set out in clause 3.1, with a total of 5 (five) prize winners ("**Prize Winners**") receiving Prizes during the course of the Competition Period.
- 4.2 All Qualifying Entrants will be submitted into a lucky draw to be held every Monday during the Competition Period. Prize Winners will thereafter be announced on the relevant social media platform (Facebook or Twitter) where they entered the Competition.
- 4.3 Successful entry data will be extracted by the Standard Bank finance team each week during the Competition Period and submitted for entry into the lucky draw to be held every Monday during the Competition Period.
- 4.4 If a reasonable number of attempts to contact a Prize Winner over social media, over a 48 (forty-eight) hour period fails, for whatever reason, we will re-draw a Prize Winner at random by lucky draw and the Prize Winner which we were unable to contact will no longer be eligible for the Prize.
- 4.5 The Prize Winners will receive the Prize by courier, within 14 (fourteen) days of the end of the Competition Period.

5. **GENERAL**

- 5.1 **These Terms may be amended by Standard Bank at any time, with or without notice.**
- 5.2 We are the promoter of the Competition. Any reference to **we/us/our** includes our directors, members, partners, sponsors, employees, agents, suppliers, contractors or consultants, where the context allows for it.

- 5.3 These Terms are governed by the Consumer Protection Act 68 of 2008, which will apply to this Competition and all other information relating to the Competition (including any promotional or advertising material that is published).
- 5.4 By entering this Competition all entrants agree to be bound by:
- 5.4.1 these Terms.
- 5.5 If a Prize Winner does not accept a Prize, if an entry is not valid for any reason whatsoever, if an entrant has breached these Terms, if a Prize Winner renounces a Prize, or if we deem such Prize Winner to have renounced the Prize, we reserve the right to declare the Prize be forfeited and to choose a new Prize Winner in our sole and absolute discretion.
- 5.6 A Prize may not be exchanged for any other item. We do however reserve the right to substitute a Prize with any other prize of a similar commercial value.
- 5.7 ***Audits may be conducted on all customer registrations to ensure compliance with the Financial Advisory and Intermediary Services act 37 of 2002 and all other applicable laws.***
- 5.8 ***All Prize Winners who accept a Prize do so entirely at their own risk.***
- 5.9 ***We will need to process your Personal Information (as such term is defined in the Protection of Personal Information Act 4 of 2013 to validate your entry and if you are a Prize Winner, to make the Prize available to you.***
- 5.10 ***We will be entitled to publish each Prize Winner's name and photograph in any advertising, promotional, print, point of sale or public relations material (the nature and manner of such releases to be determined within our sole discretion), for a period of one month from the date of announcing such Prize Winner. Each Prize Winner will be given the opportunity to decline the publication of their images and to participate in our marketing material insofar as it relates to the Competition.***
- 5.11 No entry will be valid until a validation process has taken place.
- 5.12 In the event of a dispute, our decision will be final and binding on all aspects of the Competition.
